

TOWN OF FIFIELD REGULAR BOARD MEETING
MINUTES OF October 1, 2015

ROLL CALL: Meeting was brought to order on October 1, 2015 at 6:30 p.m. at the Fifield Town Hall. Roll Call: D. Noetzel, J. Hintz, and J. Wierzba present. Also present were S. Putnam and 3 others.

MINUTES: Motion (Hintz, Noetzel) to accept the minutes of the September 17, 2015 regular board meeting and the September 23, 2015 special board meeting. Motion approved, voice vote.

TOWN CREW REPORT: T. Fleming asked when the no wake buoys and fire boat should be removed from the Pike Lake Chain of Lakes. The board said anytime. Fleming contacted B. Fleitner regarding her services for soil testing at W7179 Balsam Street. He reported that she no longer provides such services as she is working for the WI DNR. Other options could be REI or MSA. D. Gustafson of S E H will be taking pictures of streets for the TRIP-D application. Fleming reported that the crew is almost done graveling Brahmstadt.

FIRE DEPARTMENT REPORT: In W. Felch's absence, no Fire Dept. #1 report was given. T. Mantor, Fire Dept. #2 reported that there were no calls. He has new people wanting to take Fire Fighter classes. He reported that it looks like the Pike Lake Chain Firefighters will be donating \$25,000 in 2016 for equipment upgrade.

DISCUSS REQUEST FROM THE FOOD SHARE EMPLOYMENT AND TRAINING PROGRAM TO USE THEIR VOLUNTEERS: No action was taken at this time. Next summer, if needed, use of volunteers would be considered.

DISCUSS REDUCED SPEED LIMIT FOR STATE HWY 13: Motion (Hintz, Wierzba) to support Price County Highway Safety Commission's decision on the speed limit on State Highway 13. Motion approved, voice vote.

2016 BUDGET REVIEW: The budget was finalized. The Public Hearing and Special Town Meeting on the 2016 Budget was schedule for November 5, 2015 with the Public Hearing to start at 6:00 and the Special Town Meeting to follow.
