

TOWN OF FIFIELD REGULAR BOARD MEETING  
MINUTES OF June 21, 2018

**ROLL CALL:** Meeting was brought to order on June 21, 2018 at 6:30 p.m. at the Fifield Town Hall. Present: K. Balzar, J. Hintz, J. Wierzba. Also present T. Birchell, T. Fleming, J. Jontry and 13 others.

**MINUTES:** Motion (Hintz, Balzar) to approve the Minutes of the June 7, 2018 Regular Board Meeting. Motion approved, voice vote (3, 0).

**TOWN CREW REPORT:** T. Fleming reported that the representative at American Asphalt notified him that they can not pave as scheduled due to ongoing impact from the weather emergency in Superior. They are unsure of a timeline and will continue to wait for roads to open. The town crew was working on removing a boulder at the north end of West Central Avenue. Regarding the paving project in the Town Hall parking lot, a sewer line required repair; the base has been laid and paving will ensue. A washout on Gates Lake Road/FR 146 was repaired on Tuesday.

**APPROVE ALCOHOLIC BEVERAGE LICENSE RENEWALS:** Motion (Hintz, Balzar) to approve the 2018 Alcoholic Beverage License Renewals for: Fifield Grocery, Fifield Station, Northwoods Supper Club; Northernaire Bar & Grill, Hicks' Landing, Idle Hour Resort, Kountry Kafe, Merri Cassidy's, Moose Jaw Resort, and Musky Jack's. Motion approved, voice vote (3, 0).

**DISCUSS COCHRAN LAKE COMMITTEE REQUEST TO PAVE CY'S DRIVE:** K. Balzar shared e-mails from four residents (Buckna, LeGrand, Bauer, Hoppe). Several residents (R. Schaeve, R. Cook, F. Sevcik, J. Marone) commented about living on Cy's Drive and why it should be paved. T. Fleming will do a new traffic count and obtain current price for chloride to help with dust control. K. Balzar indicated that the Board will need to review the 5-year plan and discuss it before any decision will be made. F. Sevcik asked if we could add gravel; T. Fleming stated that adding gravel would be lost to grubbing stumps, etc., but he will check into availability and obtain estimates. Further discussion was tabled and will be on the Agenda for the July 5th Board Meeting.

**DRIVEWAY ACCESS PERMITS:** The Board approved one driveway access permit for Draak on Fish Trap Road.

**PUBLIC COMMENT:** F. Sevcik remarked that the sign on Springstead Road needs to be corrected. T. Fleming will order a new one.

**CORRESPONDENCE:** J. Jontry received a letter from the DOA regarding municipal contracts for supplies. K. Balzar received a letter regarding T. Faller's work release with restrictions, as well as a letter drafted by our Attorney to send to T. Faller indicating that no position is currently available that would accommodate his restrictions. Mr. Faller has been placed on a leave of absence.

**REVIEW INVOICES:** Motion (Hintz, Wierzba) to accept invoices for payment. Motion approved, voice vote (3, 0).

**ADJOURN:** Motion to adjourn at 7:55 p.m. (Balzar, Wierzba). Motion approved, voice vote (3, 0).
