

TOWN OF FIFIELD REGULAR BOARD MEETING  
MINUTES OF September 6, 2018

**ROLL CALL:** Meeting was brought to order on September 6, 2018 at 6:30 p.m. at the Fifield Town Hall. Roll Call: K. Balzar, J. Hintz, J. Wierzba. Also present were B. Felch, T. Fleming, J. Jontry and 5 others.

**MINUTES:** Motion (Hintz, Wierzba) to approve the Minutes of the August 16, 2018 Regular Board Meeting. Motion carried, voice vote (3, 0).

**TOWN CREW REPORT:** T. Fleming reported the steps into the river in Movrich Park have been repaired. The mowing tractor power steering pump is being repaired. The Federal dug in two culverts on Riley Lake Road with our assistance. Ted would like to attend a right-of-way class in Tomahawk in October; the Board approved. K. Balzar stated that M. Beuning of the Forest Service is receiving complaints about FR 142; the Board directed Ted to grade it at this time.

**FIRE DEPARTMENT REPORT:** Fire Department #1: B. Felch reported the department responded to two motorcycle accidents on Highway 70 including one fatality, and a cabin fire which was a total loss and is under review by the Fire Marshall. Two firefighters are currently in training and an additional two will be coming on board. Fire Department #2: T. Birchell reported to K. Balzar that the company selling the firetruck was meeting with him tonight to discuss costs.

**DISCUSS FOREST HOME CEMETERY RATE SCHEDULE:** Per an e-mail from M. Behling, new rates were suggested for cremated remains and full burials (see attached Rate Schedule). The Board agreed that the suggested amounts are reasonable. **MOTION (Wierzba, Hintz) TO CHANGE THE PRICES FOR GRAVE OPENINGS AND CLOSINGS FOR FULL BURIALS AND CREMATED REMAINS PURSUANT TO THE ATTACHED RATE SCHEDULE. Motion carried, voice vote (3, 0).**

**UPDATE ON CY'S DRIVE:** K. Balzar spoke with the Wisconsin Towns Association attorney. We can not send letters to the residents asking them to agree to current road location. Due to questions of current road location versus the platted road location, a survey would need to be completed to determine platted road accuracy. If it is not correct, the plat would need to be amended, which is a process through the court system.

**APPROVE MURAL PROJECT FOR FIFIELD FIRE HALL:** B. Salm discussed plans for the mural to be painted on the north wall of the fire hall as well as possible future locations. **MOTION (Hintz, Wierzba) TO APPROVE THE MURAL PROJECT FOR THE FIFIELD FIRE HALL. Motion approved, voice vote (3, 0).**

**DRIVEWAY ACCESS PERMITS:** None.

**PUBLIC COMMENT:** None.

**CORRESPONDENCE:** J. Jontry presented an e-mail and samples of the new Price County Visitors Guide. We will continue the same ad with the addition of our website information.
